**DEFENDANT'S FATHERS MOTION TO DISMISS UNDER CRIMINAL  
PROCEDURE KAN STATUTE § 22-3208 AND NOTICE OF ILLEGAL DETAINMENT  
& NOTICE OF INTENT TO FILE LAWSUIT AGAINST JOCO D.A UNDER SECTION 1983**

**COMES NOW** the Defendant and Father to two minor alienated children, shows unto the Court the Grounds

for dismissal of this case under Kan. Stat. § 22-3208 Criminal Procedure, Pleadings - Section (2) Any defense or objection which is capable of determination without the trial of the general issue may be raised before trial by motion.(4) The motion to dismiss shall be made at any time prior to arraignment or within 21 days after the plea is entered. The Court is appropriate to immediately dismiss this case, where a Mother has weaponized a Minor Child, in the Complaint, as this Case must be dismissed due to Lack of Personal and Subject Matter Jurisdiction. The Following facts are verified by Case Records 18-CV03813 and Defense to the Division M3 being without jurisdiction over the Defendant in the wrongful complaint are as follows:

1. The Petitioner Mother Janelle Escalante, has alleged to Gardner Kansas Police Detective on or around December 7th, 2023, that the Defendant Father has 'knowingly, violated' a restraining order pursuant to KSA 38-2243, KSA 38-2244, KSA 38-2255 or KSA 60-1607.

Which if true would be a Class A person misdemeanor. But that can't true by factual deduction:

- a. There is only ONE superceding Order of even close to nature of the above four statutes and it's not those four statutes. So when it is shown to this criminal courtroom it will be viewed of Janelle Escalante abuse of minor children and of father by malicious deceptive practice of abusing the Domestic Violence statutes of the State of Kansas.
- b. On October 18, 2023, the Division 14 corrupt civil misconduct Judge Paul W Burmaster issued Doc 307 in Case 18-CV03813. Doc 307 attached hereto as Exhibit A, specifically and directly states on its page 2 and 3, that Doc 307 is pursuant 60-254, a Summary Judgement. No where in the Order alleged violated cites of the four statutes that the Assistant District Andrew J Jennings wrongfully informed Judge of Division M3 court on February 9, 2024, to bring an illegal arrest warrant and unlawful detainment. That is all Fact. February 9, 2024 was 72 hours after Matt Escalante appropriately docketed a Motion to Dismiss another fraud criminal case against him brought by Janelle Escalante, Christopher T Wilson and Assistant District Attorney Andrew J. Jennings in Case 23-DV00908. That case has not convicted nor can convict cause Jennings seen lying in the Complaint document of a 'false witness' generic entry who had not been contacted by July 5.

The detective in that Case, verifies in multiple statements in police report 23-001873, that he reportedly never contacted that Generic Witness account until July 19, 2023. Jennings knew that and that Assistant District Attorney Jennings's perjury against the best interest of my children and the County and State. Mr. Escalante also that calls that perjury reporting to the DA's office by Detective Jeffrey Brenneman in 23-DV00908.

c. And low and behold, we have Detective Brenneman and Andrew J Jennings names on another criminal complaint of this Case 24-DV00174. And Defendant showing Grounds for Dismissal of Case and should be terminations of Jobs with District Attorney office and Gardner Police Dept.

2. The other factual argument that also affirms dismissal of this case technically can't even be prosecuted is of an Order pursuant KSA 60-607 was in existence up to October 18, 2023. It is affirmed by Exhibit A, Doc 307 overruled the Order pursuant 60-607 that was issued on June 30 2022. That Order wrongfully separated cherished companionship of dad with his daughters. The alleged violation even if the State wants to claim its violation, it can't because it was gone on Oct 18, 2023. But the Order from June 30, 2023 was pursuant KSA 60-1607 and it required 'personal service' of such a purported civil order alleged violated in verbiage of Complaint Doc#1 of this case.

b. Complaint Doc #1 of 24-DV00174 purportedly stems out of 18-CV03813 Escalante vs. Escalante. A high conflict divorce where father has been consistent with truthful claims supported by facts that Mother has immorally, wrongfully, and illegally weaponized her minor children along with false claims aimed at father as a result of her not properly handling nor managing her feelings or resentments in divorce. Mother refusal to Grow after divorce has constitutionally injured children and just put a civil judge behind a Protection Order case 24-CV00369 Matthew Escalante vs Judge Burmaster, and it also has the Chief Judge of this court in Kansas High Court under claims in Escalante vs Droege 2:23-CV02536 that Chief is illegal tampering with the civil dockets of 22CV03391 and 18-CV03813, keeping the self representing father out of his own kids cases. That cased just had to be Stayed 24 hours ago by the Defendant Droege as judicial immunity is compromised.

3. The above Points number 1 and 2, the State and Court and pick either and will still have to dismiss this case But Standard of the Law of the Civil Case of 18-CV03813 verifies that Bullet Point #1 and its subsections a-c, affirm that Doc 307 pursuant KSA 60-241 was the Order in Place on the Alleged December 7th 2023. And Therefore no criminal charge can brought under the KSA 60-241 by a Complaint Doc #1 of 24-DV00471, wrote by Andrew J Jennings, in a second act of Perjury, as Ms Janelle has attempted to Deceive the Criminal Court, the Gardner Police and the DA's office. But Jennings should has done his due diligence and had Brenneman fully investige but all parties show knowlege of Mother false claims so they just helped

her purge and they did too in 24-DV00172. Defendant is a Father, not a Defendant. And there is perjury showing by parties. Matthew Escalante demands Charge be brought against Janelle Escalante for the illegal actions described above of deceit to fool an M3 courtroom and judge of an Order that was superceeded on Oct 18, 2023. Doc 307 cannot held as a Charge that is described in Complaint Doc #1 There is clear and visible lack of personal and subject-matter jurisdiction.

This case MUST dismiss immediately to serve in the interest of Justice. And Charges need to filed against Ms. Escalante for perjury reporting to the DA/Court of Division M3 and Judge Sample.

Father again pointing to Complaint Doc #1 where Mother has weaponized minor child S.J.E, in deception perjury to the GPD/DA's Office/Division M3. And Illegal Detainment of Matthew Escalante again occurred.

WHEREFORE, the Defendant shows facts that satisfy dismissal as Appropriate of this Case. And the Defendant requests all other other relief that is Justified to Stop Ms. Escalante from further harming children and father with false claims. That is a justified request. We, Children and Father, are victims of Janelle Escalante's procedure abuse of the Kansas Domestic Violence system and we demand relief and charges pressed.

**JOURNAL ENTRY OF JUDGMENT AND FINAL ORDER**

NOW ON THIS 18<sup>th</sup> day of October, 2023, this matter comes on for hearing. Petitioner appears not but by counsel, Christopher Wilson. Respondent appears with appointed counsel, Edward Bigus. The Court considers the record and the arguments of Respondent Father, his counsel, and Petitioner’s counsel. Whereupon the Court finds and orders as follows:

1. Over a year ago, on June 30, 2022, Father was ordered by this Court to exercise a handful of supervised parenting sessions at The Layne Project due to disturbing messages he had sent to the children.
2. Father made clear to the Court that he would “take a knee” and not see his children until after the first of the year.
3. The Court implored Mr. Escalante to reconsider, to visit his children, to work with the Guardian Ad Litem, and to re-establish a normal parenting routine with his children.
4. **Since that time, Father has steadfastly refused to see his children.**
5. The Court has done all it can to encourage Father to see his children. The Court has asked Father, the Court has explained that seeing the children would be in their best interest, the Court has threatened Father with contempt, and the Court has even sentenced Father to 30 days in jail --- all to no avail. Even at no cost to him, Father has refused to visit his

children.<sup>1</sup>

6. **Father has steadfastly refused to see his children and refused to provide all but the tiniest of financial support.**
7. Instead of seeing or supporting his children, Father has focused on harassing Mother, her counsel, the Court, and others with frivolous lawsuits and absolutely false allegations on the internet.
8. The Court has been as patient as it can be with Father but sees no just reason for further delay.
9. The parties have been divorced for several years and the Court has made plain that only two issues remain in this case: parenting time and child support.
10. The Court will leave the issue of child support to the Hearing Officer.
11. Regarding parenting time, the Court finds pursuant to K.S.A. 23-3203 that it is in the best interests of the minor children that Mother have sole decision-making custody of the children as Father has refused to see his children. Further, as Father has actively estranged himself from the children, Father will exercise no time with the children or contact the children by any means until he contacts Livingston Counseling, begins reintegrative therapy with the children at his expense, and produces a report from the therapist recommending expanded time with the children. He is directed to contact Livingston Counseling without delay. The Court will consider no motions *of any kind* by Father until he complies with the Court's order.

<sup>1</sup> Today, Father provided a wholly non-credible excuse for not visiting his children as ordered. His attempt to blame The Layne Project was simply nonsensical. However, the Court declined to send Father to jail because the point of the 30-day sentence was not to incarcerate Father but instead to persuade him to visit his children. It is clear now he refuses to see his children and will go to lengths to ensure that he doesn't.

12. This final order and judgment is issued in accordance with K.S.A. 60-254. Parties are advised they may appeal this decision.
